



A GLOBAL ERP

Mago4 is an ERP designed in international perspective, because it speaks several languages, manages foreign currencies and different tax regulations. Mago4 ERP meets any need thanks to globalization functionalities able to support complete international localizations.

MULTILINGUAL INTERFACE

The Mago4 user interface can be displayed in multiple languages *. The dictionaries are freely available for installation, and the language can also be set up at individual user level.

The same information system can therefore be used in a globalized company.


The Multilanguage management refers also to the access from outside via the Internet, making it easier to share information with customers and partners abroad.

MULTILINGUAL DATA

Mago4 allows you to manage several data to be described in multiple languages.

You can indicate the descriptions of items, accounting accounts, terms of payment, transport, etc. in one or more alternative languages of your choice, and use those descriptions to compose or print documents (eg.: orders, invoices, account statements, but also budgets and financial statements) intended to foreign counterparts.

* Available languages: Bulgarian, English, French, German (Switzerland), Hungarian, Italian, Polish, Portuguese, Romanian, Spanish.



MULTICURRENCY MANAGEMENT

No more problems linked to the use of different currencies and foreign exchange. Thanks to Mago4 you can define the exchange rates between currencies, with a day - by - day variable rate, or more rates in the same day. You can also choose a change of sale different than the one of purchase.

Any document can be expressed in a different currency and attributed to a fixing, manually exchangeable (negotiation of the exchange rate).



If required, all prices, amounts etc. from other files are converted on the currency document.

The price lists in foreign currencies are managed, too.

The reference to the currency is maintained throughout the document life cycle. At the moment of payment, the program will be able to automatically calculate the active or passive exchange difference and simultaneously account it.

You can define accounts in foreign currency (eg. to manage a bank or cash account in another currency), and automatically reconcile credits and entries in another currency at the year end, to draw up the balance sheet.

INTERNATIONAL LOCALIZATIONS

Mago4 knows how to manage tax regulations and operating practices of various countries**.

It is quite seamless user experience: the localization is activated during installation by selecting the country for which you want to use the product. For example, for the Romanian or Polish configuration, the Documents Correction will be used instead of the Credit Notes, the Intrastat file paths or VAT payment will be adjusted to local regulations, etc. It is important to note that the regulations in use is unrelated to the language used by the user interface: it is perfectly allowed, for example, to use the program with the Romanian configuration in the Italian language interface, and so on; providing an easier remote monitoring of IT systems, Mago4 localization features are crucial for companies with offices or production sites abroad, providing easier remote monitoring of IT systems.


MANAGE ALL CURRENCY
